Honorary Life Membership Criteria and Procedures of Nomination

Scope and Process

Honorary Life Member is a significant award granted by the Sexual Health Society of Qld (SHSQ). Life members are not required to pay an annual financial fee and they receive all the benefits enjoyed by a member of the society however does not have voting rights. This award is based on the following criteria and members nominating a particular candidate should:

- 1. Ensure that the nominee fits the majority of these criterion:
 - Current membership of the Sexual Health Society of Qld
 - Longer term commitment to SHSQ as evidenced by at least 5 years continuous membership.
 - The nominee is no longer active or working within Queensland
 - The nominee is of good standing
 - Has contributed to the SHSQ in an executive or leadership role at some time
 - Made a significant contribution to furthering the aims and goals of the Society
- 2. Provide documentation supporting the nomination. Pertinent information would include but not necessarily be limited to the following.
 - The nominee's contribution to SHSQ
 - The nominee's length of membership of the Society
 - The nominee's contribution to the Society and how this has advanced sexual health in Qld.

Selection Procedures

The executive, chaired by the President will examine the nominations received and taking into account the criteria for Honorary Life Membership, make a recommendation to the Committee. The Executive will, if it accepts the recommendation, pass a resolution to bestow an Honorary Life Membership on the nominated member(s). The committee shall have absolute discretion in determining who should receive the Honorary Life Membership



Informing the Nominated Member(s)

The President should write to each nominee and inform them of this nomination.

- 1. That he or she has been nominated by the Executive for Honorary Life Membership
- 2. That the bestowal of the Honorary Life Membership will occur at the next Annual General Meeting of the Society
- 3. That the candidate is invited to attend the AGM for the presentation

Informing the Decision of the Executive

The decision of the Executive will be recorded in the minutes and following the President's letter to the nominee and the nominee's acceptance of the Honorary Life Membership, the decision will be included in the documents sent to all members prior to the Annual General Meeting.

Bestowing the Honorary Life Membership

The SHSQ committee will arrange for a time during the AGM for the bestowal of the Honorary Life Membership. This will include

- 1. The President to present a profile of the candidate that provides justification for the bestowal
- 2. Have the candidate respond
- 3. Have the President bestow the Honorary Life Membership certificate

The Honorary Life Membership Certificate

A certificate will be presented to the Honorary Life Membership that registers the Honour bestowed by the Society
